

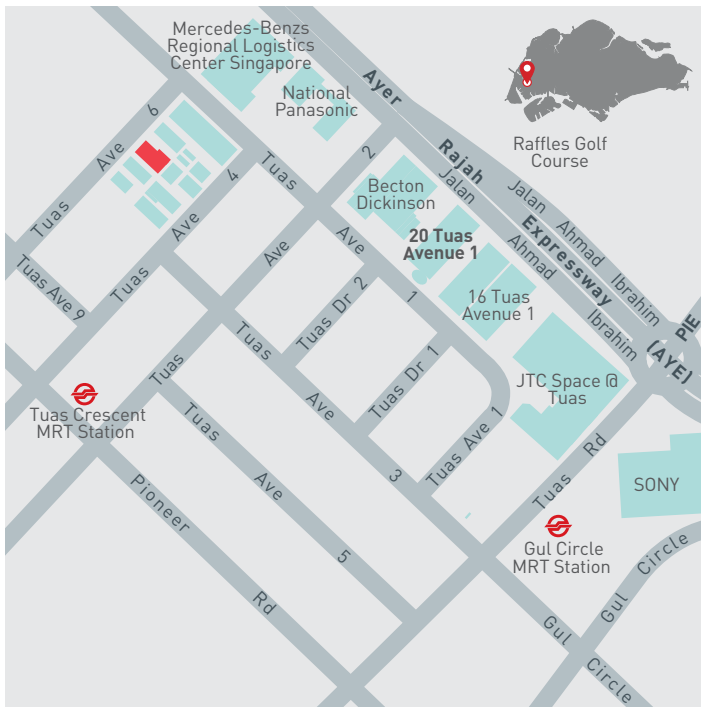


20 TUAS AVENUE 6

20 Tuas Avenue 6 is a three-storey standalone warehouse facility. Located in the western part of Singapore, it is easily accessible via the Ayer Rajah Expressway and is in close proximity to the Tuas Checkpoint.

- Ancillary Office
 - 1st - 3rd storey: Approx. 327 sqm each
- Ancillary Area
 - 1st storey: Approx. 9 sqm
 - 2nd storey: Approx. 110 sqm
- Warehouse
 - 1st storey: Approx. 3,130 sqm
 - 2nd storey: Approx. 855 sqm

Floor Loading

- Ancillary Office
 - 1st - 3rd storey: 4.0 kN/sqm
- Warehouse
 - 1st - 2nd storey: 12.5 kN/sqm

Ceiling Height

- Floor to floor
 - Ancillary Office
 - 1st storey: 4.0 m
 - 2nd storey: 3.2 m
 - 3rd storey: 3.0 m
 - Warehouse below Mezzanine: 5.1 m
 - Warehouse Mezzanine: 5.4 m
 - Warehouse: 10.5 m

Column Grid

- 1st - 3th storey: Approx. 9.4 m x 11.4 m

Parking Lots

- Car: Approx. 8
- Lorry: Approx. 3

Power Supply Allocation

- Approx. 400 amps (3-Phase)

Provisions

- Manual call points, fire alarm panels, hosereel and fire extinguishers serving the whole building

Amenities

- Eating house in the vicinity

- 5 minutes' drive to Tuas Checkpoint and 15 minutes' drive to Jurong Port
- 5 minutes' walk to bus stop with bus no. 192
- Walking distance to Tuas Crescent MRT station

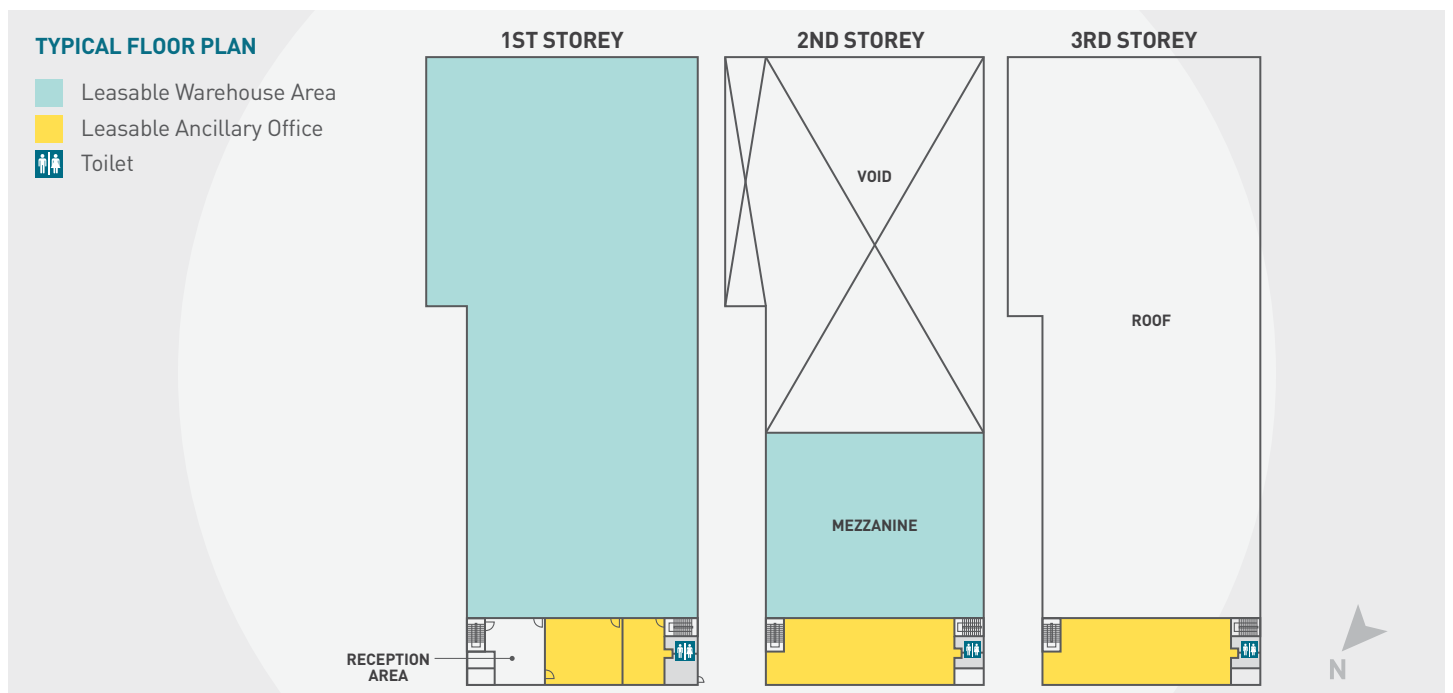
