Terms & Conditions

1. INTRODUCTION

1.1. The Dining Table (the “**Promotion**”) is exclusive to members of CapitaStar (referred to as “Eligible Shopper”). Shoppers can download the CapitaStar mobile application and sign up within the App as a member to qualify and participate in this promotion. **Eligible Shoppers can pay via eCapitaVoucher or by linking their Mastercard, DBS/POSB cards, DBS PayLah!, or ShopBack Pay to the CapitaStar app.** CapitaStar [rewards](#) are only awarded for spend at participating CapitaLand malls and/ or commercial properties in Singapore.

1.2. The Promotion is organised by CapitaLand Retail Management Pte Ltd (“Organiser”) and shall be governed by these terms and conditions (“**T&Cs**”)

1.3. The promotion period (“**Promotion Period**”) is from 8 July to 31 December 2026, both dates inclusive. Promotion is available daily from 12PM – 9PM.

1.4. The Promotion mechanics are as follows:

1.4.1. Upon spending the minimum transactional value at CQ @ Clarke Quay as shown in the table below (“Qualifying Spend”), Eligible Shoppers will receive the relevant amount of eCapitaVoucher (“Reward”).

- 1.4.2. The Reward will be automatically credited directly into the CapitaStar App of the Qualifying Eligible Shopper upon successful verification of the qualifying spend.
- 1.4.3. Eligible Shoppers must pay via their linked Mastercard, DBS/POSB card, DBS PayLah!, ShopBack Pay (linked to the CapitaStar app), with a minimum transactional value of Singapore Dollars Eighty (S\$80) and/or Singapore Dollars Forty eCapitaVoucher (S\$40 eCV) or more in a single transaction from any participating Food & Beverage stores at CQ @ Clarke Quay on the same day (“Eligible Transaction”) to qualify for the Promotion.
- 1.4.4. The **Reward** in this Promotion will be available for redemption via linked Mastercard, DBS/POSB card, DBS PayLah!, ShopBack Pay (linked to the CapitaStar app) or eCapitaVoucher payment modes on each same day of the Promotion Period.
- 1.4.5. Purchases made via cash will not be eligible. The **Qualifying Spend** must be made via **Mastercard, DBS/POSB card, DBS PayLah!, ShopBack Pay (linked to the CapitaStar app) or eCapitaVoucher** to be eligible.
- 1.4.6. The Reward in this Promotion is provided on a first-come, first-served basis and redemption is subject to availability, while stocks last.
- 1.4.7. The Organiser reserves the right to vary or amend any terms & conditions at any time, without prior notice, and without liability. In case of any dispute, the Organiser’s decision shall be final and not appealable.
- 1.4.8. The **Reward** awarded with the Qualifying Spend will expire within ONE calendar year from date of transaction. Eligible Shoppers can tap on the “eWallet” tab from the CapitaStar App main screen to view the Reward and the expiry date. The Organiser shall not be obliged to entertain any request to extend the validity of the Reward.
- 1.4.9. The **Reward** offered is non-transferable, non-exchangeable, and no cash alternative is offered. No requests for extensions or replacements whatsoever will be entertained.
- 1.5 The **Reward** may take up to 7 working days to be issued.

2. ELIGIBILITY

- 2.1. Without limiting the generality of the above, the following persons shall **not be eligible** for the Promotion:
- 2.1.1. employees of any retail tenants in CQ @ Clarke Quay; and
- 2.1.2. persons who the Organiser may decide to exclude at its discretion without notice and without providing any reason, at any time.

2.2. The Organiser reserves the right to disqualify any member who is found at any time (whether before or after the purchase of any Reward) to be in breach of the relevant eligibility or qualifying criteria. Any Reward awarded to any member may be forfeited, and if collected, shall be returned to the Organiser promptly and may be dealt with the Organiser's sole discretion.

3. QUALIFYING SPEND

3.1. Only the total final amount paid via **Mastercard, DBS/POSB card, DBS PayLah!, ShopBack Pay (linked to the CapitaStar app) or eCapitaVoucher** as indicated on the tax invoice(s)/ transaction(s) at the participating store(s) will be accepted for this Promotion.

3.2. Notwithstanding Clause 1.4 of this Terms and Conditions hereinabove, transaction(s) from purchase of parking coupons, purchase or top up of Cashcard / stored value cards, purchase or top up of stores' membership card, gift cards and vouchers (i.e. eCapitaVoucher or participating stores' vouchers), transactions from pushcarts and stalls at temporary roadshows, and transactions from supermarkets (FairPrice Finest) are not eligible for use as a transaction in this Promotion. For purchases of goods and services made by instalments, only the amount paid via eCapitaVoucher made on the same day of the redemption, will be eligible for use as a transaction in this Promotion for CapitaStar Rewards programme. eCapitaVoucher from deposit placements, order placements, and payments using tenant / credit card loyalty points will not be accepted for the purposes of this Promotion.

3.3. The Organiser may reject any amount paid via eCapitaVoucher as invalid at its sole and absolute discretion, and such determination shall be final and conclusive.

3.4. The Organiser reserves the right to verify all purchases made by the Eligible Shopper before processing the redemption of the Reward in the Promotion.

3.5. Transactions shall be considered expended for the purposes of this Promotion and other promotions in the CapitaLand Malls when it is used to redeem the Reward. Eligible payment modes and transactions cannot be used for redemption of multiple Rewards. Eligible payment modes and transactions cannot be used for redemption of more than one promotion at any CapitaLand Mall.
