

Stylish Rewards @ Funan

1. INTRODUCTION

CapitaStar rewards are only awarded for spend at participating CapitaLand malls and/ or commercial properties in Singapore.

1.2 The Promotion is organised by CapitaLand Retail Management Pte Ltd (“Organiser”) and shall be governed by these terms and conditions (“**T&Cs**”)

1.3 The promotion period (“**Promotion Period**”) is from 20 March to 3 May 2026, both dates inclusive. Promotion is available daily, from 10am to 10pm.
