TERMS & CONDITIONS

Stylish Rewards Terms & Conditions

1. Style On Point at Plaza Singapura (the “Promotion”) is exclusive to members of CapitaStar Rewards (referred to as “Eligible Shopper”) as at the start of the Promotion Period. CapitaStar Rewards (Refer to CapitaStar Rewards Programme) will only be awarded for the qualifying spend at participating retailers at Plaza Singapura, refer to Annex 1 for the full participating list.
2. The Promotion is organised by CapitaLand Retail Management Pte Ltd (“Organiser”) and shall be governed by these terms and conditions (“T&Cs”).
3. The promotion period (“Promotion Period”) is from 20 March to 3 May 2026, both dates inclusive, Monday to Friday (“Weekday”) and Saturday & Sunday (“Weekend”).

 - The eCapitaVoucher reward awarded in this Promotion will expire in three (3) months from the date of issuance. The Organiser shall not be obliged to entertain any request to extend the validity of the eCapitaVoucher rewards.
- (d) Receive one (1) \$10 tenant eVoucher with the reward code <SPRING26>:
- Upon keying in the reward code “SPRING26” in their CapitaStar app, Eligible Shoppers can redeem an eVoucher worth Singapore Dollars Ten (\$10) (“Reward”).

For avoidance of doubt, DBS/POSB Mastercard cardmembers must link their CapitaStar account on DBS PayLah! and link their DBS/POSB Mastercard on the CapitaStar app for transactions to be captured as both DBS/POSB and Mastercard transactions.

Any Reward awarded to any member may be forfeited, and if collected, shall be returned to the Organiser promptly and may be dealt with the Organiser's sole discretion.

14. Qualifying Spend

14.1 Only the total final amount paid at the participating store(s) using eCapitaVoucher, linked Mastercard credit or debit card, DBS/POSB payment modes (including DBS/POSB American Express, Mastercard, VISA credit or debit cards and/or DBS PayLah!) or ShopBack Pay will be accepted for this Promotion.

14.2 Transactions(s) from car grooming services, purchase of parking coupons, purchase or top up of Cashcard / stored value cards, purchase or top up of stores' membership card, gift cards and vouchers (i.e. eCapitaVoucher or participating stores' vouchers), SISTIC transactions, AXS / SAM machines transactions and bill payments, any transactions at money changer, bank and other financial institutions' transactions, transactions from pushcarts and stalls at temporary roadshows, transactions at GP, Dental and Specialist Clinics, and transactions at supermarkets (CS Fresh) are not eligible for use as a transaction in this Promotion.
