ASSET VALUATION

Pursuant to Rule 703 of the **SGX-ST** Listing Manual, the **Manager** wishes to announce that the **Manager** has obtained new independent valuations, as at 30 June 2010, for the Singapore properties owned by **CCT** as listed below.

Excluding Robinson Point, which was sold on 19 April 2010, the value of **CCT**'s Singapore properties, including its 60.0% interest in Raffles City through RCS Trust, is S\$5,493.8 million in aggregate based on the valuations as at 30 June 2010. This represents a downward valuation of S\$25.7 million or approximately 0.5% from the aggregate value of S\$5,519.5 million as at 31 December 2009 for the same properties.
