ISSUANCE OF HKD885,000,000 IN AGGREGATE PRINCIPAL AMOUNT OF FIXED RATE NOTES DUE 2023 PURSUANT TO THE US\$2,000,000,000 EURO-MEDIUM TERM NOTE PROGRAMME

CapitaMall Trust Management Limited (the **Manager**), as manager of CapitaMall Trust (**CMT**), refers to the announcement dated 16 November 2012 in relation to the proposed issue of HKD885,000,000 3.28% fixed rate notes due 27 February 2023 (the **Notes**) to institutional and/or sophisticated investors, pursuant to the US\$2,000,000,000 Euro-Medium Term Note Programme established by CMT MTN Pte. Ltd. (the **Issuer**) on 29 March 2010 as updated on 12 March 2012 (the **EMTN Programme**).

The Manager wishes to announce that the Notes, which are unconditionally and irrevocably guaranteed by HSBC Institutional Trust Services (Singapore) Limited, in its capacity as trustee of CMT (the **Guarantor**), have been issued by the Issuer on 27 November 2012.

Approval in-principle has been granted by the Singapore Exchange Securities Trading Limited (the **SGX-ST**) for the listing and quotation of the Notes on the SGX-ST and the Notes will be listed and quoted on the SGX-ST with effect from 9.00 a.m., Wednesday, 28 November 2012. Admission of the Notes to the Official List of the SGX-ST and quotation of the Notes on the SGX-ST is not to be taken as an indication of the merits of CMT, the Issuer, the Guarantor, their respective subsidiaries and associated companies, the Manager, the EMTN Programme or the Notes.

Pursuant to Rule 704(31) of the Listing Manual of the SGX-ST, the Manager wishes to announce that the EMTN Programme contains a condition where it is an event of default under the terms of the notes issued under the EMTN Programme if the Manager is removed as manager of CMT and the replacement or substitute manager is not appointed in accordance with the terms of the trust deed constituting CMT (the **Trust Deed**). If the condition is breached, it may trigger cross defaults under the other facilities, debt issues and borrowings of CMT and/or its subsidiaries. In such an event, the aggregate level of facilities, debt issues and borrowings of CMT and its subsidiaries which are outstanding and that may be affected is approximately S\$3,320.5 million (including the Notes but excluding interest) as at the present date.

As at the date of this announcement, there has not been a breach of the condition described above.
