PAYMENT OF MANAGEMENT FEES BY WAY OF ISSUE OF UNITS IN ASCOTT RESIDENCE TRUST

Ascott Residence Trust Management Limited (the “**Company**”), as manager of Ascott Residence Trust (“**Ascott REIT**”), wishes to announce that a total of 1,797,692 units in Ascott REIT (“**Units**”) have been issued at an issue price of S\$1.4321 per Unit to the Company today as partial payment of the base fee and base performance fee (collectively, the “**Management Fees**”) for the period from 1 January 2013 to 31 March 2013 (both dates inclusive).

The balance of the Management Fees of S\$677,629 (excluding applicable goods and services tax) was paid in cash. The aforesaid Management Fees are computed in accordance with the provisions stipulated in the deed of trust dated 19 January 2006.

With the above-mentioned issue of Units, the Company holds an aggregate of 57,362,178 Units, representing 4.55% of the total number of Units in issue of 1,261,595,671.
