CapitaCommercial Trust Management Limited, as manager (the "**Manager**") of CapitaCommercial Trust ("**CCT**"), wishes to announce that S\$17,000,000 in aggregate principal amount of S\$225,000,000 2.7 per cent. convertible bonds due 2015 (the "**Convertible Bonds**") have been converted and cancelled. This is due to an exercise of conversion rights by the holders thereof.

Together with the current conversion, the total principal amount of **Convertible Bonds** converted and cancelled up to the date of this announcement is \$17,750,000. Following the conversion and cancellation, the aggregate principal amount of **Convertible Bonds** remaining outstanding as of 9 May 2013 is S\$207,250,000.

Arising from the conversion, an aggregate of 13,794,222 new units in **CCT** (the "**Units**") has been issued at the conversion price of S\$1.2324 per **Unit**, and the total **Units** in issue is 2,860,803,896.
