### PAYMENT OF MANAGEMENT FEES BY WAY OF ISSUE OF UNITS IN ASCOTT RESIDENCE TRUST

Ascott Residence Trust Management Limited (the “**Company**”), as manager of Ascott Residence Trust (“**Ascott REIT**”), wishes to announce that a total of 2,625,955 units in Ascott REIT (“**Units**”) have been issued at an issue price of S\$1.2748 per Unit to the Company as partial payment of the base fee and base performance fee (collectively, the “**Management Fees**”) for the period from 1 January 2015 to 31 March 2015 (both dates inclusive).
