#### **CHANGE OF NAME OF CCT AND THE MANAGER**

---

CapitaLand Commercial Trust Management Limited (formerly known as CapitaCommercial Trust Management Limited), as manager of CapitaLand Commercial Trust (formerly known as CapitaCommercial Trust) ("**CCT**", and as manager of CCT, the "**Manager**"), refers to Rule 704(2) read with Rule 404(8)(a) of the Listing Manual of Singapore Exchange Securities Trading Limited (the "**SGX-ST**") which requires an issuer to disclose any proposed alteration to the constitution of the issuer.

The Manager wishes to announce the following changes to the particulars of CCT and the Manager:

(a) **Change of name of CCT**

The name of CCT has changed from "CapitaCommercial Trust" to "CapitaLand Commercial Trust" with effect from today. In addition, the Manager has received notification from the SGX-ST that the following security names will be changed with effect from 8 May 2015, before trading opens:
